Period of service: As listed above.


Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 31 October 2005 to 22 September 2006, Headquarters and Headquarters Company, 43d Military Police Brigade and its subordinate units displayed exceptionally meritorious service in support of Operation Iraqi Freedom. The Brigade was tasked with the control and accountability of over 15,000 detainees, and it was instrumental in supporting the adjudication process of a record number of terror suspects in accordance with Iraqi Law, thereby removing them as a threat to Iraqi people and Coalition Forces. Additionally the unit's efforts to strengthen and enforce the rule of law in Iraq enabled the emerging Iraqi Government to more actively participate in the processing, rehabilitation, and release of detainees, allowing them to return as more productive members of society. The unit was also instrumental in the planned transition operations of the Iraqi government by developing and managing a transition plan that included the training of over 1,500 Iraqi correctional officers. These efforts resulted in the seamless closure of both the Abu Ghraib and Fort Suse detention centers, as well as the renovation, and expansion of Camps Remembrance II and Bucca, thus vastly improving Iraq's correctional infrastructure. Headquarters and Headquarters Company, 43d Military Police Brigade's outstanding performance of duty is in keeping with the finest traditions of military service and reflects distinct credit upon the unit, the United States Army National Guard, and the United States Army.
