Award: Meritorious Unit Commendation

Period of service: 30 April 2010 to 18 April 2011

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 30 April 2010 to 18 April 2011, Headquarters and Headquarters Detachment, 7th Transportation Battalion and the cited units distinguished themselves not only by the scope and complexity of its deployment mission, but by the manner in which it was conducted. The units defined their deployment by conducting first rate maintenance, training Soldiers above the standard, placing Soldiers' welfare at the forefront of decision making and by placing mission accomplishment above all else. In total, the units provided responsive tailored and adaptive heavy equipment transport to more than ten different Forward Operating Bases and covered a distance of more than 21,619,183 flat bed miles completed. Furthermore, convoys hauled over 30,000 pieces of equipment while completing 689 missions with supplies and retrograde equating to over 10,000,000 short tons of cargo. Headquarters and Headquarters Detachment, 7th Transportation Battalion and the cited units' dedication to the mission and exemplary performance set the standard for the transportation battalions on Camp Arifjan and reflect great credit upon the units, the 1st Sustainment Command (Theater) and the United States Army.

The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned.
