Announcement is made of the following award:

Award: Meritorious Unit Commendation

Period of service: 4 December 2011 to 3 September 2012

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 4 December 2011 to 3 September 2012, Headquarters and Headquarters Detachment, 22d Military Police Battalion and the cited units displayed exceptionally meritorious service to the United States in support of Operation Enduring Freedom. The units conducted Title 10 Felony Criminal Investigations; criminal intelligence, forensics, expeditionary forensic lab oversight, host nation investigative and mentoring support in the Afghan theater of operations in order to support United States Forces and host nation Rule of Law. The 22d Military Police Battalion and the cited units conducted over 800 investigation actions to include 480 felony criminal investigations. Headquarters and Headquarters Detachment, 22d Military Police Battalion and the cited units' actions are keeping with the highest traditions of military service and reflects great credit upon themselves, the 6th Military Police Group, the United States Criminal Investigation Division Command and the United States Army.

The award is still subject to final confirmation in Department of the Army General Orders. Official verification of a specific unit's entitlement to display the award in the form of an appropriate streamer on its flag or guidon rests with the U.S. Army Center of Military History (CMH), which is also responsible for determining official unit Lineage and Honors for MTOE organizations. CMH will use this permanent order to authorize the manufacture of an appropriate decoration streamer for any organization clearly entitled to display the award. The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned. It is not the responsibility of HRC to replace streamers that are lost or damaged. Please refer to AR 840-10 for further guidance regarding the responsibilities of the unit concerning the display, care and disposition of the streamers.
