Reason: For exceptionally meritorious service. During the period 12 September 2012 to 18 May 2013, the 3d Squadron, 7th Cavalry Regiment displayed exceptionally meritorious service in support of Operation Enduring Freedom. It is not the responsibility of HRC to replace streamers that are lost or damaged.
