Announcement is made of the following award:

Award: Meritorious Unit Commendation

Period of service: 1 February 2013 to 7 February 2014

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. The Combined Joint Task Force-101 and the cited units distinguished themselves by exceptionally meritorious service from 1 February 2013 to 7 February 2014 in Regional Command-East, Afghanistan. During this period, the Soldiers, Coalition Partners and Civilians of Combined Joint Task Force-101 made tremendous progress in enhancing security and stability to set conditions for transition of civil control to the Government of the Islamic Republic of Afghanistan and the retrograde of Coalition Forces. The command created a unified team that was integrated in all operations and committed to working with and through Afghan institutions. Significant improvement was made to separate insurgents from the Afghan population and build Afghan trust in their government by focusing efforts on key terrain districts. Combined Joint Task Force-101 supervised and resourced remarkable progress in building the capability and capacity of the Afghan National Security Forces, as well as district and provincial governments through combined action and partnership.
