Award: Army Superior Unit Award

Period of service: 1 July 2012 to 30 June 2013

Authority: AR 600-8-22, paragraph 7-16

Reason: During the period 1 July 2012 to 30 June 2013, the Headquarters and Headquarters Company, 705th Military Police Battalion and the cited units displayed outstanding devotion and performance of an exceptionally difficult mission. The units simultaneously conducted Change of Command, Change of Responsibility, a technical visit by the Army Corrections Command, correctional training to Active Duty and National Guard units and accreditation by the Army Correctional Association. The Mid-West Joint Regional Correctional Facility received a perfect score marking the first occasion of a flawless initial inspection earned by any military corrections facility. CMH will use this permanent order to authorize the manufacture of an appropriate decoration streamer for any organization clearly entitled to display the award. The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned.
