2. ON 18 SEP 2014, THE SECRETARY OF THE ARMY AUTHORIZED THE ARMED FORCES EXPEDITIONARY (AFE) CAMPAIGN STREAMER FOR OPERATIONS RESTORE HOPE AND UNITED SHIELD IN SOMALIA FOR THE PERIOD OF 5 DEC 1992 – 31 MAR 1995.

THE CENTER OF MILITARY HISTORY HAS VERIFIED THE UNITS THAT ARE ELIGIBLE TO RECEIVE THIS STREAMER AND HAS PROVIDED THIS INFORMATION TO THE AWARDS AND DECORATIONS BRANCH FOR PUBLICATION OF ARMY GENERAL ORDERS (AGO). AGO 2014-73 AUTHORIZES CAMPAIGN PARTICIPATION CREDIT FOR OPERATIONS RESTORE HOPE AND UNITED SHIELD IN SOMALIA AND CAN BE VIEWED AT WWW.APD.ARMY.MIL. UNITS LISTED IN AGO 2014-73 MAY REQUISITION STREAMERS THROUGH THE TACOM WEBSITE AT WWW.HERALDRY.ARMY.MIL BY ENTERING THE UNIT IDENTIFICATION CODE (UIC) AS PART OF THE REQUEST. TACOM WILL PROCESS REQUESTS AND PROVIDE THE APPROPRIATE STREAMER. STREAMER REQUESTS ENTERED WITH INVALID/UNAUTHORIZED UICS WILL BE REJECTED. ELIGIBLE UNITS ARE REMINDED THAT CERTIFICATES WILL NOT BE ISSUED WITH THIS AFE CAMPAIGN STREAMER AS CERTIFICATES ARE ISSUED WITH UNIT AWARDS.

4. UNITS THAT PARTICIPATED IN OPERATIONS RESTORE HOPE AND UNITED SHIELD IN SOMALIA BUT ARE NOT LISTED IN THE AGO MAY REQUEST AUTHORIZATION FOR THE AFE

STREAMER BY SUBMITTING THEIR REQUESTS TO THE U.S. ARMY HUMAN RESOURCES COMMAND, (AHRC-PDP-A), DEPARTMENT 480, 1600 SPEARHEAD DIVISION AVE, FORT KNOX, KY 40122-5408. ALL REQUESTS WILL BE SUBMITTED BY MEMORANDUM AND INCLUDE THE FOLLOWING SUPPORTING DOCUMENTATION: DEPLOYMENT ORDERS AND A UNIT ROSTER OF PARTICIPATING SOLDIERS. WHEN ACTING ON BEHALF OF AN INACTIVATED UNIT, THE REQUESTOR WILL INCLUDE THIS INFORMATION IN THE MEMORANDUM.
