
Reason: For exceptionally meritorious service. During the period 26 June 2007 to 10 April 2008, Headquarters and Headquarters Detachment, 1144th Transportation Battalion and its subordinate units displayed exceptionally meritorious service in support of Operation Iraqi Freedom.
