Award: Army Superior Unit Award

Period of service: 7 July 2008 to 6 July 2009

Authority: AR 600-8-22, paragraph 7-16

Reason: For outstanding meritorious service. During the period 7 July 2008 to 6 July 2009, Headquarters and Headquarters Company, 1st Battalion, 11th Aviation Regiment and its subordinate units displayed outstanding meritorious service in support of the Global War on Terrorism. The battalion coordinated over 1.8 million aircraft movements, with aircraft operating under all modes of flight, including visual flight rules, instrument flight rules, daylight and nighttime conditions, and while utilizing night vision goggles. The unit achieved this record without a single air traffic control related accident or incident. The unit also amassed 107 Control Tower Operator certifications, Ground Control Approach ratings, and Airspace Information Services ratings. Additionally, the battalion trained 61 Army National Guard Soldiers, providing them with the necessary skills to earn 5 Ground Controlled Approach ratings in preparation for deployment. Further, the battalion provided air traffic control services and navigational instrument maintenance in support of the Federal Aviation Administration's National Airspace Mission for the southeastern United States. Headquarters and Headquarters Company, 1st Battalion, 11th Aviation Regiment's outstanding performance of duty is in keeping with the finest traditions of military service and reflects distinct credit upon the unit and the United States Army.
