Reason: For exceptionally meritorious service. During the period 12 June 2008 to 1 September 2009, Headquarters and Headquarters Company, 1st Maneuver Enhancement Brigade and its subordinate unit displayed exceptionally meritorious service in support of Operation Enduring Freedom.
