Reason: For outstanding meritorious service. During the period 20 February 2007 to 5 March 2008, the Joint Attack Munition Systems Project Office, U.S. Army Program Executive Office, Missiles and Space displayed outstanding meritorious service in support of Operations Iraqi and Enduring Freedom. Formed by the merger of the former Aviation Rockets and Missiles Project Office and the Joint Common Missile Project Office, the unit repeatedly responded to the needs of operational commanders by solving problems and pushing solutions to the field. In addition, the unit provided life cycle management and improvements for the HYDRA-70 rocket system, the HELLFIRE, Longbow HELLFIRE, and HELLFIRE II missile systems, the VIPER STRIKE munition, the Joint Air-to-Ground Missile program, and all associated launchers and test equipment. The unit actively worked with warfighters to refine requirements and fill capability gaps in the air-to-ground munition mission area and has become the Joint Warfighter's Center of Excellence for arming unmanned armed systems. The actions exhibited by the Joint Attack Munition Systems Project Office, U.S. Army Program Executive Office, Missiles and Space are in keeping with the finest traditions of military service and reflect distinct credit upon the unit and the United States Army.
