Award: Valorous Unit Award

Period of service: 16 November 2005 to 15 November 2006

Authority: AR 600-8-22, paragraph 7-14

Reason: For extraordinary heroism in action against an armed enemy. During the period 16 November 2005 to 15 November 2006, Headquarters and Headquarters Detachment, 3d Ordnance Battalion and its subordinate units displayed extraordinary heroism in action against an armed enemy in support of Operation Iraqi Freedom. By positioning themselves between the dangerous improvised explosive devices designed to target and eradicate them and their Coalition brothers and sisters, the joint teams of Headquarters and Headquarters Detachment, 3d Ordnance Battalion displayed the greatest example of selfless service and loyalty. Their bravery and sacrifice saved countless Coalition and Iraqi lives, and provided critical protection to the infrastructure of Iraq. Their support to the war resulted in the destruction of over 400,000 pounds of hazardous explosives and materials to make improvised explosive devices, critically hindering the ability of Anti-Iraqi Forces to disrupt and eradicate Coalition Forces. Headquarters and Headquarters Detachment, 3d Ordnance Battalion's outstanding performance of duty is in keeping with the finest traditions of military service and reflects great credit upon the unit and the United States Army.

The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned.
