Award: Meritorious Unit Commendation

Period of service: 27 September 2004 to 25 September 2005

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 27 September 2004 to 25 September 2005, the 1075th Transportation Company displayed exceptionally meritorious service to the Coalition Forces Land Component Command while serving in support of Operation Iraqi Freedom. The 1075th Transportation Company distinguished itself as an exceptional unit by providing timely and responsive convoy logistical support throughout the theater during intense combat operations. The unit conducted more convoys across more miles than any other transportation company in the Iraqi area of operations with over 300 missions and five million miles. The unit's extraordinary execution of its mission helped the Coalition Forces Land Component Command sustain the mission with transportation of equipment moving to and from the sea and air ports of debarkation into critical areas of Iraq. The outstanding and historic performance of the Soldiers of the 1075th Transportation Company is in keeping with the highest traditions of military service and reflects great credit upon the 106th Transportation Battalion, the 37th Transportation Group, the 143d Transportation Command, the 377th Theater Support Command, the Third Army Coalition Forces Land Component Command and the United States Army.
