Award: Meritorious Unit Commendation

Period of service: 22 March 2010 to 13 March 2011

Reason: For exceptionally meritorious service. During the period 22 March 2010 to 13 March 2011, the 632d Transportation Detachment displayed exceptionally meritorious service in support of Operation Enduring Freedom. The unit provided 24-hour movement control and velocity management operations by processing, staging and pushing forward more than 30,000 surface deployment distribution command and host nation trucks carrying critical equipment and rolling stock supporting the uplift of three brigade combat teams, one combat aviation brigade and 30,000 U.S. Forces throughout Regional Commands-South, West and Southwest. The actions, commitment to excellence and mission execution of the unit significantly improved Kandahar Airfield's logistics throughput procedures and capabilities.
