Award: Meritorious Unit Commendation

Period of service: 1 August 2009 to 1 February 2010

Authority: AR 600-8-22, paragraph 7-15


Reason: For exceptionally meritorious service. During the period 1 August 2009 to 1 February 2010, Headquarters and Headquarters Company, 2d Special Forces Battalion, 7th Special Forces Group, 1st Special Forces Regiment and its subordinate units displayed exceptionally meritorious service in support of Operation Enduring Freedom. The unit planned and executed sustained combat operations against a determined enemy insurgent force, ultimately denying sanctuary to the anti-Coalition militia and leading to the destruction of anti-Coalition militants and expulsion of terrorist organizations. The actions of the unit led directly to the stability and legitimacy of the government of Afghanistan. During these sustained combat operations the unit executed combat, support and humanitarian assistance missions; supervised the infiltration and combat operations of three Special Forces companies; and set the conditions for victory against a hidden enemy throughout Afghanistan. By its exemplary performance of duty, Headquarters and Headquarters Company, 2d Special Forces Battalion, 7th Special Forces Group, 1st Special Forces Regiment and its subordinate units have brought great credit upon the unit, Combined Joint Special Operations Task Force-Afghanistan, Special Operations Central Command and the United States Army.
