Announcement is made of the following award:

Award: Meritorious Unit Commendation

Period of service: 23 May 2011 to 15 May 2012

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 23 May 2011 to 15 May 2012, the 152d Transportation Detachment displayed exceptionally meritorious service in support of Operation Enduring Freedom. The unit performed Afghan truck/surface movement regulation as well as air terminal operations functions. The unit processed more than 10,000 host nation/national Afghan trucks, fuel tankers, supreme food trucks and Surface Deployment and Distribution Command trucks. The 152d Transportation Detachment operated the fixed and rotary wing passenger and cargo terminal, and processed over 80,000 passengers and 10,000 short tons of cargo. The unit executed movement control operations for the reception, staging and onward integration of two Brigade Combat Teams and established the Forward Operating Base Shank aerial port as a viable point of embarkation and debarkation for Brigade Combat Team deployments and redeployments. The mission execution and commitment to excellence of the unit set a new standard for air and ground operations. The actions of the 152d Transportation Detachment are in keeping with the highest traditions of military service and reflect great credit upon its Soldiers, the unit, the 257th Transportation Battalion, the Joint Sustainment Command-Afghanistan and the United States Army.
