Award: Meritorious Unit Commendation

Period of service: 1 July 2011 to 20 June 2012

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 1 July 2011 to 20 June 2012, the 140th Transportation Detachment displayed exceptionally meritorious service in support of Operation Enduring Freedom. The unit processed and tracked all inbound and outbound cargo via host nation trucking and National Afghan Trucking from Bagram Airfield Entry Control Point-3. The unit provided accurate and timely information that allowed the in-transit visibility of more than 115,000 cargo trucks carrying all classes of supply. The actions of the 140th Transportation Detachment ensured mission-critical supplies were delivered to Warfighters and support personnel throughout the Afghan theater of operations. Its actions are in keeping with the finest traditions of military service and reflect great credit upon its Soldiers, the 257th Transportation Battalion, the Joint Sustainment Command-Afghanistan and the United States Army.
