Award: Meritorious Unit Commendation

Period of service: 23 December 2012 to 1 September 2013

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 23 December 2012 to 1 September 2013, the 930th Support Detachment distinguished themselves through exceptional and exemplary achievement while forward deployed to the Afghan-Pakistan border in Nangarhar Province, Afghanistan, in support of Operation Enduring Freedom. The unit enabled communication and contact between the Afghan National Security Forces, Pakistani Military and International Security Assistance Forces across the tactical, operational and strategic domains. The collective actions of these Servicemen and civilians enabled tripartite routine and informal communication even when diplomacy was most tense across the border and between the nations. The Soldiers, Airmen and civilians of the Khyber Joint Border Coordination Center provided sustained positive effects that will enable positive Afghan and Pakistani relations along the shared border in conjunction with the International Security Assistance Force and North Atlantic Treaty Organization efforts long into the future.
