Announcement is made of the following award:

Award: Meritorious Unit Commendation

Period of service: 1 June 2012 to 22 February 2013

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 1 June 2012 to 22 February 2013, the 18th Transportation Detachment operated the passenger terminal, aerial movement request cell, cargo documentation team and the Joint Distribution Management Center at Bagram Airfield, Rotary Wing Mission at Camp Phoenix as well as the Rotary Wing and United States Combined Air Terminal Operations at Kabul Afghanistan International Airport. The unit processed and provided in-transit visibility of over 334,000 inbound personnel; 365,000 outbound personnel, 37,800 short tons of cargo and over 3,750 aerial cargo movement requests. The unit superbly processed more than 5,706 Transportation Movement Requests, burned over 6,500 Radio Frequency Identification Tags, and printed over 6,500 Military Shipping Labels and Transportation Control and Movement Documents. The unit's mission execution and commitment to excellence set a new standard for air, ground and National Afghan Trucking operations. The actions of 18th Transportation Detachment are in keeping with the highest military traditions and reflect great credit upon its Soldiers, themselves, the 49th Joint Movement Control Battalion, the 311th Expeditionary Sustainment Command and the United States Army.

CMH will use this permanent order to authorize the manufacture of an appropriate decoration streamer for any organization clearly entitled to display the award. The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned. It is not the responsibility of HRC to replace streamers that are lost or damaged. Please refer to AR 840-10 for further guidance regarding the responsibilities of the unit concerning the display, care and disposition of the streamers.
