Award: Meritorious Unit Commendation

Period of service: 25 July 2012 to 11 April 2013

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 25 July 2012 to 11 April 2013, the 632d Transportation Detachment operated the vehicle entry control point, movement control cell, National Afghan Trucking cell and Xeless contract. The unit processed and provided in-transit visibility of over 25,000 logistics movement requests, 50,000 transportation movement requests, 200,000 short tons of cargo and in-gated and out-gated over 100,000 logistic assets. Then unit's mission execution and commitment to excellence set a new standard for Xeless and National Afghan Trucking operations. The actions of 632d Transportation Detachment are in keeping with the highest military traditions and reflect great credit upon themselves, the 49th Joint Movement Control Battalion, the 311th Expeditionary Sustainment Command and the United States Army.
