Award: Army Superior Unit Award

Period of service: 25 October 2012 to 25 December 2012

Authority: AR 600-8-22, paragraph 7-16

Reason: For outstanding meritorious service. During the period 25 October 2012 to 25 December 2012, the United States Army Garrison, Fort Hamilton distinguished itself through meritorious service. Designated as a Base Support Installation and the only active Army Garrison in the New York City area, providing essential services and vital support which enabled humanitarian assistance and disaster relief efforts to all New York City boroughs (Brooklyn, Manhattan, Long Island, Staten Island, Bronx and Queens) before, during and after Hurricane Sandy made landfall. The unit was rapidly able to expand into a Base Support Installation, a mission it is not resourced for, conducting all operations non-stop. Many of whom, sustained severe economic loss in their own hurricane ravaged communities. The staff remained vigilant and reported to work with enthusiasm, dedication to duty and selfless service. With many thousands desperately seeking services, with nowhere else to turn, mission accomplishment was paramount. The United States Army Garrison, Fort Hamilton's dedication to duty, selfless service, by providing life-line services to thousands of citizens of the state of New York and New Jersey, brings great credit upon itself, the Joint Task Force-National Capital Region and Military District of Washington, the United States Army Installation Management Command and the United States Army.

The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned. It is not the responsibility of HRC to replace streamers that are lost or damaged. Please refer to AR 840-10 for further guidance regarding the responsibilities of the unit concerning the display, care and disposition of the streamers.
