Award: Meritorious Unit Commendation

Period of service: 22 February 2014 to 22 November 2014

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 22 February 2014 to 22 November 2014, 1st Battalion, 504th Infantry Regiment and the cited units displayed exceptionally meritorious service in support of Operation Enduring Freedom XV. The units distinguished themselves by serving as the Regional Command-East Theater Reserve Force. The Theater Reserve Force provided support to the Afghan National Elections, the redeployment and retrograde of coalition infrastructure including Forward Operating Base Ghazni, the Bagram security zone and enabled Coalition Freedom of movement and operational flexibility throughout Regional Command-East. The units efforts significantly disrupted insurgent networks and helped facilitate the successful transition to resolute support. The outstanding performance and commitment to duty of the 1st Battalion, 504th Infantry Regiment and the cited units is in keeping with the finest of traditions of military service and reflects great credit upon themselves, the 3d Cavalry Regiment, the 10th Mountain Division and the United States Army.
