WAR DEPARTMENT,
WASHINGTON, August 21, 1918.

I.—The following Field Artillery cantonments are designated in honor of the men named, who contributed during their lives to the development of the United States and the acquisition by American citizenship of its present status:

Site.	Camp.	In honor of—
Stithton, Ky.....	Knox.....	Henry Knox, who was brigadier general and chief of artillery, United States Army, 1776-1782; major general, United States Army, 1782-1783; commander in chief of United States Army, 1783-1784; and Secretary of War, 1785-1794.
Fayetteville, N. C....	Bragg.....	Capt. Braxton Bragg, who, while commanding Battery C, Third Artillery, rendered signal service at the battle of Buena Vista, Mexico.

II.—1. The following camps are designated as training centers:

- Camp Lee, Va. (Infantry).
- Camp Gordon, Ga. (Infantry).
- Camp Pike, Ark. (Infantry).
- Camp MacArthur, Tex. (Infantry).
- Camp Jackson, S. C. (Field Artillery).
- Camp Zachary Taylor, Ky. (Field Artillery).
- Camp A. A. Humphreys, Va. (Engineer).
- Camp Eustis, Va. (Coast Artillery).
- Camp Hancock, Ga. (Machine Gun).

2. Their primary activity—i. e., the training of replacements heretofore known as "Replacement and training camps"—will be designated as follows: Replacements.

The use of the term "Replacement and training camp" in all tables, orders, and correspondence will be discontinued. Examples of designation are as follows:

8th Battalion, Replacements, Training Center, Camp Lee, Virginia.

6th Battalion, Depot Brigade, Training Center, Camp Pike, Arkansas.

III.—A bronze medal with suitable device and ribbon will be issued to any officer or enlisted man of the National Guard who, under orders of the President, having served not less than 90 days in the War with Spain, also served on the Mexican border in the years 1916 and 1917. This medal will not be presented to any officer or enlisted man not now in the National Guard unless he quitted it in an honorable status, nor to one who is eligible to receive the Mexican service badge heretofore authorized by the President. In case of the death of a man who would have been entitled to such medal, the medal may be presented to his family. Application for this medal will be made to The Adjutant General of the Army through military channels. The application should give the full name and address of the applicant, the rank he held, and the organization in which he served during the War with Spain and upon the Mexican border.
