Authority: AR 600-8-22, paragraph 7-16


Reason: During the period 1 January 2007 to 31 December 2007, Headquarters and Headquarters Company, 1st Signal Brigade and its subordinate units displayed outstanding meritorious service in support of the Global War on Terrorism. In addition to successfully completing its armistice mission of deterring aggression on the Korean peninsula, the brigade initiated fifty-one fielding projects, participated in humanitarian efforts, and provided continuous, uninterrupted services. The unit accomplished all of this while simultaneously conducting a radical transformation of the communications support on the Korean peninsula, and while manned at only seventy-two percent strength. Further, the unit won the 2007 Information Assurance Professional Award for the most innovative project or implementation and the Network Enterprise Technology Command's Supply Excellence Award.
