subordinate units displayed exceptionally meritorious service in support of Operation Iraqi Freedom. The unit was at the forefront of an Army that was transforming at war. As the Army's first Stryker Brigade Combat Team, the unit tested new doctrinal concepts, training methodologies, organizational structures, technology, and equipment in combat, thus providing a template for the future that will have far-reaching impacts for a generation to come. The unit executed a strategic deployment by sea, entering combat ahead of schedule and fighting as a part of the 4th Infantry Division in the Sunni Triangle city of Sammara. Soon after, the unit moved forward to northern Iraq and conducted similar relief in place of the 101st Airborne Division in Ninevah Province and Mosul, Iraq. The unit provided operational flexibility to the commanding generals of Combined Joint Task Force-7 and Multi-National Corps-Iraq. When operations required a highly mobile, versatile, and agile force, the Commanding General called on the unit. Headquarters and Headquarters Company, 3d Brigade, 2d Infantry Division's outstanding performance of duty is in keeping with the finest traditions of military service and reflects distinct credit upon the unit, 2d Infantry Division, and the United States Army.
