Award: Army Superior Unit Award

Period of service: 9 November 2005 to 21 June 2010

Authority: AR 600-8-22, paragraph 7-16

Reason: For outstanding meritorious service. During the period of 9 November 2005 to 21 June 2010, the U.S. Army Corps of Engineers and its subordinate units displayed outstanding meritorious service in the execution of \$26 million of Base Realignment and Closure 2005 and American Recovery and Reinvestment Act construction requirements during Fiscal Years 2006-2010. U.S. Army Corps of Engineers exceeded Army and Department of Defense metrics for execution of funding and implemented innovative business processes and strategies to

CMH will use this permanent order to authorize the manufacture of an appropriate decoration streamer for any organization clearly entitled to display the award. The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned.
