Reason: For outstanding meritorious service. During the period 5 November 2009 to 16 January 2010, Headquarters and Headquarters Detachment, 11th Military Police Battalion and its subordinate units displayed extraordinary meritorious service in response to an active shooter incident at Fort Hood, Texas that became one of the most horrendous and infamous crimes to occur on a United States Army installation. Undaunted by the chaos, size and complexity of the incident, the unit maintained an exceptionally superior performance while responding and leading a Joint Multi-Agency Task Force criminal investigation into the largest mass homicide of Soldiers in the history of the United States Army. The Headquarters and Headquarters Detachment, 11th Military Police Battalion and its subordinate units' exceptional performance to assist, protect and defend the Fort Hood community during this tragic event is keeping with the finest traditions of the United States Military and reflects distinct credit upon the unit, the United States Army Criminal Investigation Command, the Military Police Corps and the United States Army.

The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned.
