Award: Army Superior Unit Award

Period of service: 1 October 2009 to 30 September 2010

Authority: AR 600-8-22, paragraph 7-16

Reason: For outstanding meritorious service. During the period 1 October 2009 to 30 September 2010, Headquarters, U.S. Army Materiel Command displayed superior performance of a difficult and challenging mission. The unit was responsible for global logistics operations of unprecedented size and scope. Headquarters, U.S. Army Materiel Command oversaw the reset and redistribution of nearly three million equipment items throughout the transition from Operation Iraqi Freedom to Operation New Dawn, while simultaneously supporting the buildup of additional U.S. forces deployed for Operation Enduring Freedom in Afghanistan. The unit successfully accomplished these demanding operational missions while optimizing the Materiel Enterprise's support for emerging Army Force Generation requirements and while realigning core competencies to maximize the efficient use of personnel and resources. In addition, during this same period, Headquarters, U.S. Army Materiel Command executed one of the most complex Base Realignment and Closure relocations within the Army. Headquarters, U.S. Army Materiel Command's outstanding performance of duty is in keeping with the finest traditions of military service and reflects great credit upon the military and civilian men and women of the U.S. Army Materiel Command and the United States Army.
