Award: Meritorious Unit Commendation

Period of service: 9 November 2010 to 8 November 2011

Reason: For exceptionally meritorious service. During the period 9 November 2010 to 8 November 2011, the 101st Sustainment Brigade and its subordinate units were distinguished by exceptionally meritorious achievement in support of Operation Enduring Freedom. The unit was responsible for planning, coordinating, executing and providing responsive, quality tactical logistical support and sustainment operations to over 50,000 United States Military, Coalition and Civilian personnel operating in six regional commands distributed to over 140 Forward Operating Bases throughout the Combined Joint Operations Area-Afghanistan, while simultaneously providing logistics mentorship to Afghan National Army Corps Support and Garrison Support Battalions.
