Reason: For outstanding meritorious service. During the period 26 October 2010 to 26 October 2011, Headquarters and Headquarters Company, Seventh United States Army Joint Multinational Training Command and the cited units displayed outstanding devotion and superior performance of their exceptionally difficult mission to provide first-class relevant and realistic training to both United States Soldiers and our allied partners in the European Command and African Command areas of responsibilities.
