Announcement is made of the following award:

Award: Meritorious Unit Commendation

Period of service: 24 April 2012 to 9 January 2013

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 24 April 2012 to 9 January 2013, Headquarters and Headquarters Troop, 8th Squadron, 1st Cavalry Regiment and the cited units distinguished themselves through extraordinary achievements while engaged in military operations against enemies of the United States of America and the Afghan people in the Islamic Republic of Afghanistan during Operation Enduring Freedom. The units also conducted combat and stability operations in and around Kandahar City, Afghanistan. The units aggressively partnered with Afghan National Security Forces in multiple operations enabling them to secure themselves. These efforts and determination of the units degraded the enemy forces within Kandahar City and contributed to defeating the insurgency in Afghanistan. CMH will use this permanent order to authorize the manufacture of an appropriate decoration streamer for any organization clearly entitled to display the award. The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned. It is not the responsibility of HRC to replace streamers that are lost or damaged.
