Award: Army Superior Unit Award

Period of service: 16 April 2011 to 10 May 2012

Authority: AR 600-8-22, paragraph 7-16

Reason: For exceptionally meritorious service. During the period 16 April 2011 to 10 May 2012, Headquarters and Headquarters Battalion, V Corps accomplished an exceptionally outstanding and unprecedented manner all requirements and activities associated with its accelerated reconstitution under the modular force structure design. The unit worked in the areas of receiving new personnel, fielding new equipment and relocating from Heidelberg to Wiesbaden Army Airfield, Germany while simultaneously planning for and conducting rigorous and effective combat pre-deployment individual and collective training. The dedicated and professional leaders, staff and Soldiers worked together and successfully accomplished these goals, while V Corps achieved initial operation capability on 1 June 2011 with complete, full operational capability on 12 August 2011. It is not the responsibility of HRC to replace streamers that are lost or damaged.
