Award: Valorous Unit Award

Period of service: 1 April 2010 to 31 August 2010

Authority: AR 600-8-22, paragraph 7-14

Reason: For extraordinary heroism in action against an armed enemy. During the period 1 April 2010 to 31 August 2010, the 3d Brigade Combat Team, 101st Airborne Division and the cited units displayed conspicuous gallantry and intrepidity in action while conducting combat operations in support of Operation Enduring Freedom in the Ghazni, Paktya, Paktika and Khowst Provinces in Eastern Afghanistan. The units demonstrated the ability to execute counterinsurgency operations and accomplish the mission beyond the call of duty. Their expertise in bringing decisive combat power to bear on the enemy wherever and whenever needed set the conditions for overwhelming victory and represents a phenomenal effort.
