Award: Meritorious Unit Commendation

Period of service: 21 March 2010 to 10 March 2011

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 21 March 2010 to 10 March 2011, Headquarters, 3d Brigade Combat Team, 4th Infantry Division and the cited units displayed exceptionally meritorious service during Operation Iraqi Freedom. The units were responsible for supporting four provincial reconstruction teams while advising and assisting the Iraqi Army, Iraqi Police and Department of Border Enforcement. Headquarters, 3d Brigade Combat Team, 4th Infantry Division and the cited units partnered with the Iraqi Security Forces to disrupt violent extremists groups in order to decrease enemy activity and provide security in the region. The units also worked to reduce the number of bases and equipment in support of the responsible drawdown of forces as the mission in Iraq changed from combat operations under Operation Iraqi Freedom to stability operations under Operation New Dawn. The professionalism and dedication to the mission of Headquarters, 3d Brigade Combat Team, 4th Infantry Division and the cited units were beyond the call of duty and greatly contributed to the success of United States Division-South. Their actions are in keeping with the finest traditions of military service and reflect great credit upon the United States Division-South and the United States Army.
