Award: Meritorious Unit Commendation

Period of service: 6 August 2012 to 22 April 2013

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 6 August 2012 to 22 April 2013 the 99th Transportation Detachment operated the main entry/exit control point and Movement Control Team ground operations at Camp Leatherneck. The unit processed over 1,200 Logistics Movement Requests, in-gated and out-gated over 38,000 Host Nation Trucking assets and over 50 mission convoys, the unit's mission execution and commitment to excellence set a new standard for ground operations. The actions of 99th Transportation Detachment are in keeping with the highest military traditions and reflect great credit upon themselves, the 49th Joint Movement Control Battalion, the 311th Expeditionary Sustainment Command and the United States Army.

The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned. It is not the responsibility of HRC to replace streamers that are lost or damaged.
