Reason: For exceptionally meritorious service, During the period 20 December 2013 to 15 December 2014, Headquarters and Headquarters Company, 508th Military Police Battalion and the cited units distinguished themselves through exceptionally meritorious conduct in the performance of outstanding service in Parwan Province, Afghanistan, supporting Operation Enduring Freedom. The units executed mission command over full spectrum of detention operations for the only theater-level detention facility in Afghanistan, ensuring the safe and humane care, custody and control of over 1,300 detainees. The units partnered with the Afghan National Army Military Police Guard Command and flawlessly conducted extensive security force assistance to train, advise and assist their Afghan National Army counterparts. Their exceptional efforts resulted in an Afghan Force capable of maintaining security and stability operations post 2014. The units were critical in the execution of the Combined Joint Interagency Task Force 435 and International Security Assistance Force's campaign plans. Their efforts resulted in the certification of the Afghan National Army Military Police Guard Command and the strategically historic transition of detention operation to an enduring Afghan National Army capacity. This justified retrograde operations and defined the end-state of the Afghanistan campaign plan.
